How to find a HS Code for a given Commodity

Method 1:

Harmonized System (HS) code from overseas exporters/ Shippers


All importers and exporters who intend to import to or export from the Marshall Islands will be required to state the eight-digit Harmonized System (HS) code for commodities when submitting ASUCUDAWorld declarations.


Traders and importers are encouraged and advised to obtain the relevant eight-digit HS codes from the overseas exporters, together with other details, at the time of requesting a pro forma or commercial invoice.


Method 2:

ASYCUDAWorld Tariff Query

Traders can also use the Tariff Querry facility in ASYCUDAWorld declaration eDocument to get the HS code of the commodity. Invoke the F3 function key from Cage 33 to get the tariff query window.




